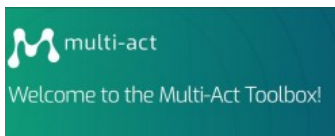


Event Report: EBC Policy Roundtable on Brain Health in Europe: Fostering Innovation, Improving Outcomes

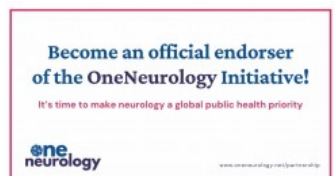

The **7th Academy Meeting of National Brain Councils** was held virtually on 15th April 2021.

Prof. **Monica Di Luca**, President of the European Brain Council, started the meeting with words of welcome to the participants, followed by an Opening Address by MEP **Tomislav Sokol** (HR, EPP) on the perspective of a European Health Union. **Pierre Delsaux**, Deputy Director-General of the Directorate-General for Health and Food Safety, delivered his keynote speech and replied to the questions from the audience, focusing on the key role of Member States in developing and establishing a European brain health agenda.
