In response to the European Commission's invitation to stakeholders to make a proposal under its next cycle of Thematic Networks under the EU Health Policy Platform (EU HPP), the European Brain Council (EBC), its members and allies launched the Thematic Network '[Towards an EU Coordination Plan for the Brain](#)'.
